2. Petitioner request that the drainage authority abandon a portion of County Ditch 22A as described herein:


The County Ditch 22A Main Tile from its upper end to a point five feet west of the west Redwood CSAH 1 highway right-of-way

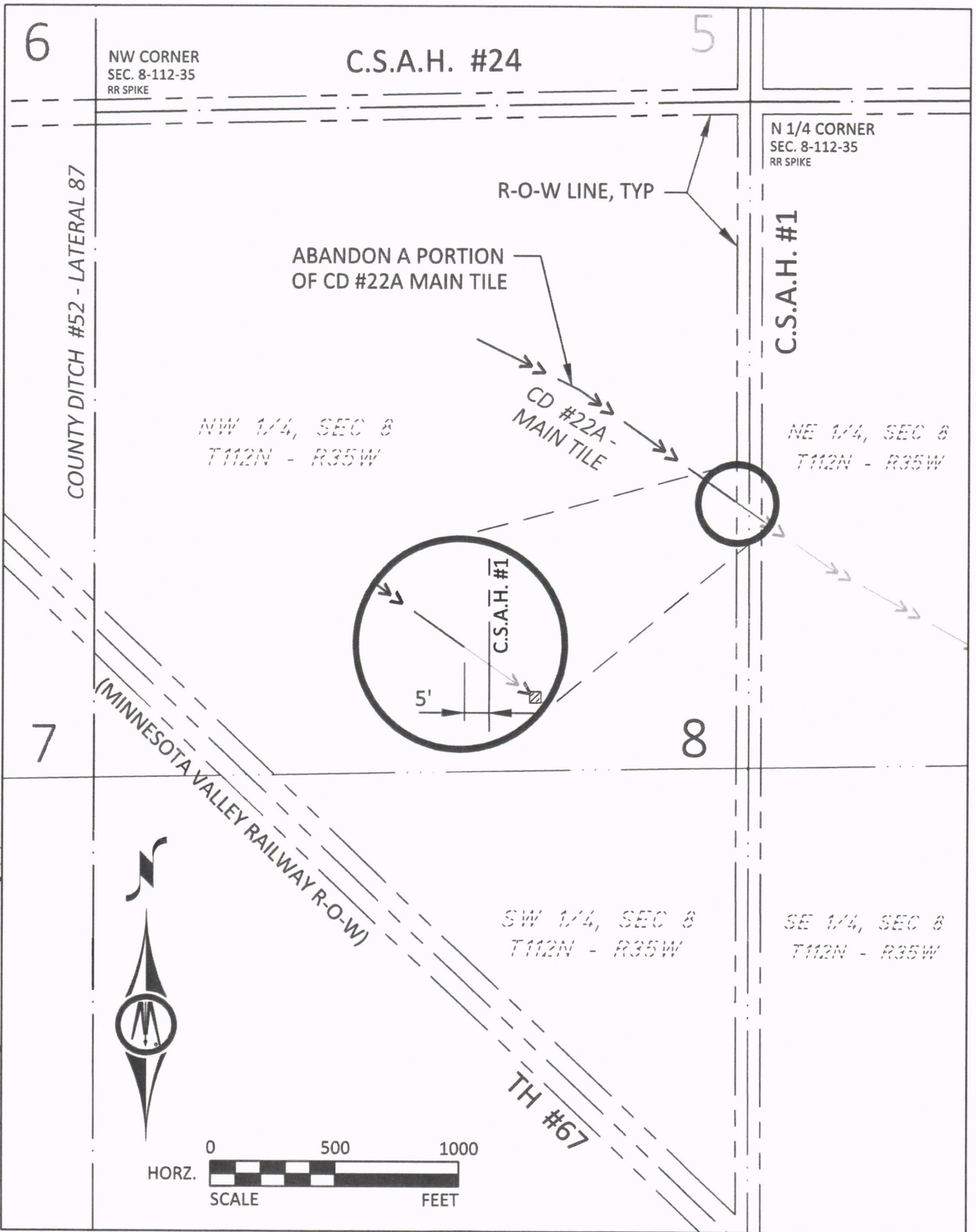

The portion of County Ditch 22A sought to be abandoned does not serve a substantial useful purpose as part of the drainage system to any property remaining in the system and is not of a substantial public benefit and utility. This area is proposed to be developed for a residential subdivision and the existing

County Ditch 22A tile route is in conflict with the proposed subdivision layout. The subdivision will have its own drainage system owned and maintained by the City of Redwood Falls.

4. Petitioners request that a public hearing, pursuant to Minn. Stat. § 103E.806, subd. 3(b), be held and to proceed to the partial abandonment of the above described portion of County Ditch 22A.
5. To the best of petitioners' knowledge, there are no outstanding drainage liens or assessments on the property related to the drainage system.
