In consideration for your participation in said reservation at a campground and/or shelter the individual, group, organization, business, spectator, or other, does hereby release and forever discharge the City of Redwood Falls Parks & Recreation Department, and its officers, board, and employees, jointly and severally from any and all actions, causes of actions, claims and demands for, upon or by reason of any damage, loss or injury, which hereafter may be sustained while using a campground or shelter. This release extends and applies to, and also covers and includes, all unknown, unforeseen, unanticipated and unsuspected injuries, damages, loss and liability and the consequences thereof, as well as those now disclosed and known to exist. The provisions of any state, federal, local or territorial law or state providing substance that releases shall not extend to claims, demands, injuries, or damages which are known or unsuspected to exist at this time, to the person executing such release, are hereby expressly waived. I hereby agree on behalf of my heirs, executors, administrators, and assigns, to indemnify the City of Redwood Falls Parks & Recreation Department and its officers, board and employees, joint and severally from any and all actions, causes of actions, claims and demands for, upon or by reason of any damage, loss or injury, which hereafter may be sustained while utilizing any campground or shelter. It is further understood and agreed that said utilization of a campground or shelter is not to be construed as an admission of any liability and acceptance of assumption of responsibility by the City of Redwood Falls Parks & Recreation Department its officers, board, and employees, jointly and severally, for all damages and expenses for which the City of Redwood Falls Parks & Recreation Department, its officers, board and employees, become liable as a result of any alleged act of those who reserved a campground and/or shelter.

Refund or Rescheduling
