County Ditch 20 is a tile system beginning in Section 9 of Kintire Township and flowing easterly until it outlets into County Ditch 12 in Section 7 of Delhi Township. The main line and its branch lines drain land in Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 23, and 24 of Kintire Township, and Sections 6, 7, and 18 of Delhi Township.

The proposed Improvement of County Ditch No. 20 includes the replacement of the Main tile with an open ditch in Section 7 of Delhi Township and Section 12 of Kintire Township, and the replacement of the Main tile and part of Branch 4 with larger tile in Sections 11 and 12 of Kintire Township.

The engineer has submitted and filed a final detailed survey report to the drainage authority. The property owner's report and the viewers' report for the improvement have been submitted and filed and the petition is pending. The drainage authority will hear a detailed survey report prepared by the engineer discussing the improvement and separable maintenance. The viewers' report for the improvement will also be heard.
